SUBJECT: ADMISSION TO DIPLOMA IN PHARMACY-UPVAID (AYURVEDIC)

SESSION 2016-17 AND ONWARDS.

GENERAL 1.

- 1.1 The Governor of Punjab is pleased to notify the procedure for admission to Diploma in Pharmacy (Ayurvedic) course for the year 2016-17 and onwards in the institutions affiliated to the Punjab State Faculty of Ayurvedic & Unani System of Medicine, Punjab.
- 1.2 All institutions whether Government/ Private/ Aided/ Unaided affiliated with the Punjab State Faculty of Ayurvedic & Unani System of Medicine, Punjab shall be covered by this notification.
- 1.3 The admission to the all institutions in the State of Punjab shall be done as per the notification/ instructions guidelines/ rules/ executive orders passed by the Government of Punjab as per provision of the Punjab Private Health Sciences Educational Institutions (Regulations of Admission, Fixation of Fee and Making of Reservation) Act, 2006 as amended from time to time.
- The Governor of Punjab is further pleased to notify that no institution shall 1.4 select candidates out of any other source in any other manner than inter-se merit of the candidate on the basis of merit in the qualifying examination. Seats shall be filed through a centralized admission committee. For admissions the candidate shall have to apply to the Principal, Government Ayurvedic College, Patiala.

2. **ELIGIBILITY CRITERIA & EXEMPTIONS**

- 2.1 Qualifying Examination: Candidate must have passed 10+2 examination or its equivalent examination as regular or open school candidate from a recognised institution situated in Punjab. Preference will be given to candidates who have passed 10+2 examination or its equivalent examination in the subjects of Physics, Chemistry & Biology/ Mathematics. If candidate(s) from Punjab are not available then candidates from other States shall also be considered.
- Age: The Candidate must have completed 17 years of age as on 31st 2.2 December of the corresponding year of admission.
- 2.3 The candidate should be bonafide resident of Punjab. The resident status of the Punjab State shall be taken in terms of Punjab Government. Department of Personnel and Administrative Reforms (PPII Branch) letter No. 1/3/95-3PPII/ 96/ 19 dated 6th June, 1996. ID No. 1/2/963PP-2/8976. Dated 7th July, 1998. ID No. letter No. 1/3/95-3pp11/ 81. Dated 1st January 1999 and any further instructions issued by the Government of Punjab in this regard.

- Waiting list of all successful candidates will be prepared by the Chairman Selection (e) Committee and the details of vacant seats shall be displayed on the website and notice board. The waiting list shall be operated by the chairman calling the candidate for counselling.
- (d) If a candidate who has deposited/ his her fee for one year, opts to surrender his/ her selection seat, ten days before the last day fixed for the admission in the given course, the institute shall not be entitled to enforce bank guarantee/ surety bond against that student for the recovery of the balance fee. However, the fee deposited for the first year shall not be refunded.
- (e) In order to ensure completion of the prescribed course (s) and period of study as well as commencement of examination(s) in time, no admission(s) adjustment(s) shall be made after 31st October of each year regardless of any vacancy(ies) that might exist or might arise there after for any reason what so ever. However, for the session 2016-17, the deadline shall be 15.11.2016 as a one time measure.
- No admission shall be made after 31st October of each year including the left over (g)
